



FESTIVAL INTERNAZIONALE DEL CINEMA D'ARTE –IXth EDITION BERGAMO 16th – 24th JULY 2010

REGULATION

Art. 1- The Festival Internazionale del Cinema Organizing Committee, in collaboration with TEAMITALIA Events, and the group effort of Public Institutions of Bergamo organizes the **IXth Edition of the Festival Internazionale del Cinema d'Arte "Premio Le Mura d'Oro"**, in order to increase Cultural and Art values through the cinematographic language. The Festival is opened to foreign and Italian producers, as well as cinema companies, associations and singles.

The Festival includes the following competitions:

• **CINEMA D'ARTE** **International Competition**

Short, medium length, features on issues and imagines regarding the world of Arts can take part to the competition: from painting to cinema, from sculpture to dance, from architecture to theatre. The artistic expressions are used to recall an era, to construct a psychological or custom testimony, to explain the world of an artist, to fix an aesthetic and critical portrait.

• **SOTTOVENTI**

International Competition

The competition is on a free subject, except the art's subject whose there is the competition Cinema d'Arte. Films have to last maximum 20 minutes.

All of the films selected for the competition must be produced after 1st January 2007.

Art. 2 - Every producer can take part to the competition with one or more titles.

Art. 3 - The Festival will take place in Bergamo from 16th July to 24th July 2010. The order of showing to the public, and all that refers to that part of the organization is exclusively pertaining to the Organizing Committee.

Art. 4 - The Organizing Committee designates the selection committee, only responsible for the admission to the competition (his decision is final) and the Jury, only responsible for awarding or not the prizes to the films.

Art. 5 - In case, and as suggested by the Jury, the Organizing Committee has the right to check the correspondence between selected films and the category they have been selected for.

Art. 6 – The films entered in competition will be judged by a Jury that may award the following prizes:

CINEMA D'ARTE

1st Prize "Premio Le Mura d'Oro"
Jury Special Prize

SOTTOVENTI

1st Prize "Premio Le Mura d'Oro"
Jury Special Prize

For any competition will be awarded special prizes at the discretion of the Organizing Committee and Jury.

Art. 7 - Videotapes sent to the Jury can not be withdrawn or replaced, except if the Organizing Committee thinks it is better not to keep them, in the interest of the Festival itself.

These enclosures are needed to enter every film:

- Complete Technical and artistic description;
- Synopsis in English language
- Filmmaker biography and filmography
- Picture, frame or still of the film, colour and b&w, possibly in digital format, giving the rights for free to press them on the catalogue of the Festival or to give them to the press.
- Author's portrait

It is possible to attach also the following material:

- Interview and discussion of the author on the film and its work in progress
- Articles and reviews about the film on international press.
- Poster and other promotional gadgets

Art. 8 – In order to enter film or films in the Festival Selection, candidates must **send the Entry Form, together with DVD videotapes** to:
Festival Internazionale del Cinema d'Arte - Via Zelasco 1, 24122 Bergamo, Italia not later than **31.03.2010**.

Art. 8.1 – Film or films for the public projection must be sent only in Betacam Sp Pal or in Dvd Pal. Subtitles in English or in Italian are demanded.

Art. 9 – From **30th April 2010** the Organizing Secretary will communicate the result and the showing date to the authors of the selected films.

Art. 10 - The filmmaker and/or the film production authorise the publication of their data on the web-site and on the official catalogue and their circulation for the press and for cultural promotional purposes.

Art. 11 – The filmmakers and/or productions of the films selected allow the screening of the selected works, the showing of pieces of their films (on TV, on-line, cinema) for commercial aims of the event (up to 120 seconds).

Art. 12 – Insurance transport and delivery costs of foreign films are to be charged to candidates. The delivery cost for the redelivery of the Betacam Sp or DVD copy of the film will be in charge of the Organizing Committee, that is not responsible for any damages due to ordinary come out of films.

Art. 13 The Organizing Committee informs that the received materials won't be given back and that all the films sent for the selection will take part at the International Art Film Library or at Festival Archive.

Art. 14 - In order to take part in the Competition, candidates must agree completely to these Regulations.

Art. 15 - Possible cases and disputes, not included in these Regulations, are pertaining to the Festival Organizing Committee.

Art. 16 – The Organizing Committee reserves the right to make, if necessary, any changes to this Regulation without notice.
